The Houston Parks Board, in partnership with Houston Parks Board LGC, Inc. (the LGC), Houston-area communities, the City of Houston, and other entities, works to improve park spaces through renovation of existing parks and construction of new improvements to provide equitable distribution of park amenities and recreation facilities for Houston's growing communities. The LGC is a Texas nonprofit local government corporation created by the City to provide support for the City's park system. HPB has a management agreement with the LGC to acquire, manage, develop, and improve parks properties on behalf of the LGC and contract for the design, development, improvement, construction, and installation of parks and open spaces. In 2010, HPB had 4 projects in design phase and 11 projects under construction.

The Houston Parks Board assists with special projects to promote cultural activities and athletic events as well as managing trust accounts for City supported park and community programs.

The Houston Parks Board's Land Acquisition Program is working towards the expansion of the City's park system, in partnership with the City's Parks and Recreation Department, Harris County Flood Control District and other entities. Our goal is to improve the quality of life for Houstonians by acquiring more parkland to ensure availability of equitably distributed park spaces as the city continues its aggressive growth. One area of particular focus is acquiring green spaces along the bayous to help improve flood prevention while providing park amenities for the community. HPB received \$2,161,918 in land donations. The Land Acquisition Program conveyed \$54,136 in land assets to the City and \$153,369 in land assets to the Houston Parks Board LGC. HPB also donated \$280,329 in land assets back to a community.

The Houston Parks Board (HPB) solicits gifts and bequests for park acquisitions, additions, and improvements within the city of Houston and the surrounding metropolitan area. From time to time, it transfers land (or funds set aside to purchase land) that it has acquired to the City of Houston or to the Houston Parks Board LGC, a Local Government Corporation that was formed to hold the parks land and improvements of HPB and to collect funds from the City and perhaps federal agencies. During this fiscal year, HPB transferred property to a community association which wanted to add the property to its community holdings but didn't have the means to purchase the property.

HPB also acts as an agent for the City of Houston regarding certain funds that it maintains on behalf of the City. One such fund provides scholarships to students. The Houston Parks and Recreation Department's A.S.K. Group determines the scholarship recipients and has HPB write a check directly to the school the student is attending. ASK monitors the initial and ongoing qualification of scholarship recipients, not HPB.
